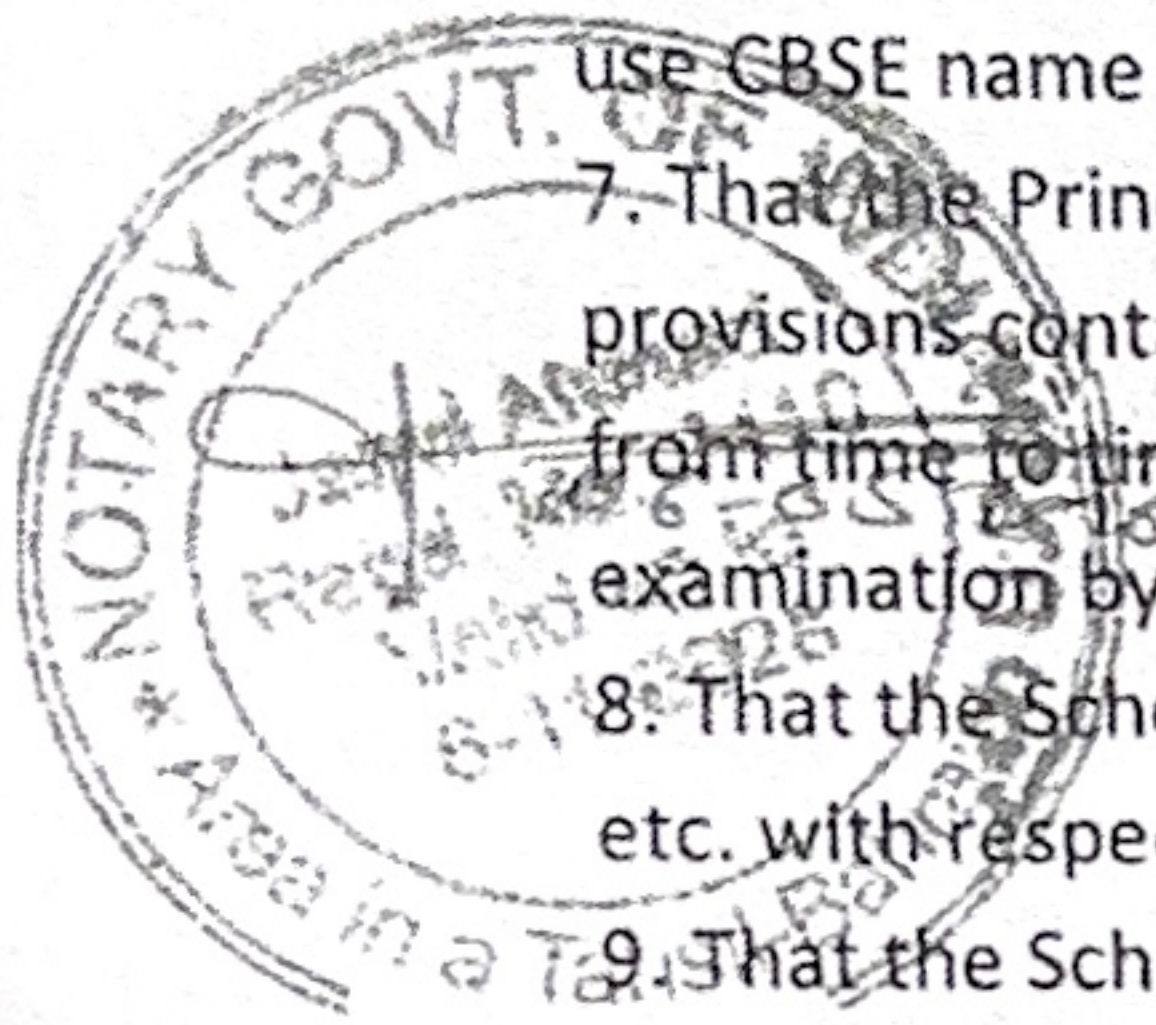




3. That the school is being run as community service and not as a business and that commercialization does not take place in the School in any manner whatsoever.
4. That no part of income from the institution is being and will be diverted to any individual in the trust/ school Managing Committee or to any other person/entity. The savings if any, after meeting and the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds, will be further utilized for promoting the School and extending the cause of education in the same school only.
5. The School is not paying any charges towards using name, motto, logo, or any other non-academic activities to any other institutions, organization or body.
6. The School will riot open classes under CBSE pattern particularly classes IX / X / XI / XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent / Manager of the School have individually gone through the provisions contained in the affiliation and examination bye laws and the circular issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliations and examination bye laws, directions issued from time to time and the law of the land.
8. That the School will ensure compliance of all statutory requirement like EPF, ESI, and Labour laws etc. with respect to the school and staff of the school.
9. That the School will ensure that the building safety, fire safety, water safety, health and hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the School will ensure that all required infrastructure is available with the school before starting classes.
11. That the School will ensure that sufficient number of qualified teachers as per the provisions contain in affiliation bye laws are available with the school before starting classes.
12. That the School will follow the provisions related to fee contained in affiliation Bye laws and will disclose the detail of the fee to the students, parent's every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the School will not force any students/ parent's to buy books/ stationary/ uniform from any particular shop.
14. That the School shall start to make efforts for conservation of environment.
15. That the School will ensure that the School fulfills all initial requirements before applying for affiliation and will fulfill all other conditions post affiliations and comply with all the general rules as given in the affiliation bye laws or noticed from time to time.
16. That in case affiliation has been with certain conditions the school will not start CBSE pattern classes without submitting all certificates / affidavit to the effect that the school has complied with the conditions imposed by the CBSE and the post condition contained in affiliation bye laws along with general rules.
